IDENTIFICATION
All voters are required to provide an ap-
proved form of identification at the poll-
ing place before receiving and casting
a ballot. Voters who are not pre-regis-
tered – such as voters registering to vote
on Election Day – and voters who have
moved precincts will also be required to
provide proof of residence. A voter who
cannot provide proof of identification may
have their identity attested to by another
voter registered in the precinct who has
an approved form of identification. For

VOTER ACCESSIBILITY
All voting sites are fully accessible to
persons with physical disabilities. Each
site also has a voter assist ballot marking
device which allows persons with sight

employer's agent, or an officer or agent
of the voter's union. Any voter who is
physically unable to enter a polling place
has the right to vote in the voter's vehicle.
